

RAVENWOOD HIGH SCHOOL CODE OF CONDUCT

Level 1 – After School Detention - Administrators Have Discretion to Assign Multiple Detentions

- The following are offenses that result in After School Detention. Multiple Level 1 Infractions could result in Level 2 or 3 Consequences.

Chromebooks	Failure to bring charged Chromebook to school will result in detention after 2nd offense
Conduct at School	Inappropriate behavior in classrooms, café, assemblies, hallways, bathrooms, parking lots, school grounds, buses
Disrespect	Inappropriate behavior or actions toward another student at school or on school grounds
Dress Code	No Hats, Proper Top Attire, Skirts and Shorts Proper Length
PDA	Public Displays of Affection that create a scene or draw undue attention
Tardies	Late Arrival to School or Late to Class - Teachers have discretion when assigning detention for Tardies to Class

Level 2 – Friday School (After School 3PM – 6PM) – Administrators Have Discretion to Assign Multiple Friday Schools

- The following are offenses that result in Friday School. Multiple Level 2 Infractions could result in Level 3 or 4 Consequences.

Conduct at School	Inappropriate behavior in classrooms, café, assemblies, hallways, bathrooms, parking lots, school grounds, buses
Disrespect	Inappropriate behavior or actions toward another student or teacher at school or on school grounds
Entrance/Exit Doors	Propping Doors, Using Incorrect Entrance/Exit Doors, Trespassing Unsupervised In Building
Parking Lots	Wreckless Driving or Dangerous Activity, Parking in Prohibited Areas or Parking Spaces
Skipping Class	Failure to report to any class, or missing more than 10 minutes of any class (Includes Study Hall, Homeroom/Lunch)
Vaping/Tobacco	Possession, Handling, Use on WCS School Grounds or School Sponsored Activities (Defined In T.C.A. §49-6-4202(3)).
Vaping/Tobacco	Includes Accessories and other products/paraphernalia used for Vaping or Smoking Tobacco

Level 3 – In School Suspension (1 to 10 Days) / Out of School Suspension (1 to 10 Days)

- The following are offenses that result in In School Suspension (ISS). Administrators have discretion to assign between 1 and 10 days of ISS based on severity and frequency of infractions. Administration may also assign Out of School Suspension (OSS) for infractions at their discretion. Multiple Level 3 Infractions could result in Level 4 or Level 5 Consequences.

Disrespect	Disrespect to any RHS Staff Member
Insubordination	Refusal to promptly comply with directions from any RHS staff member
Harassment	Physical, Verbal, Cyber, Sexual, Racial (Repeated incidents of Harassment could result in level 4 or 5 Consequences)
Profanity/Vulgarity	Profane Language or Gestures (Verbal or Hand Signs) Clothing with Profane, Vulgar, Illegal or Offensive Images
Physical Altercations	Punches, Shoving, Wrestling, Rough Horseplay that may cause injury
Technology	Use of Computers/Phones to Harass/Threaten others or Transmit Inappropriate Digital Images
Theft	Possession, Handling, or Sale of Stolen Materials
Vandalism	Damaging WCS School Property or Others Property while on WCS School Grounds or School Sponsored Activities

Level 4 – Unruly Petition / Truancy Petition

- Repeated violations of the Ravenwood High School Code of Conduct that result in Level 1, 2, and 3 consequences will result in an **Unruly** petition being filed with the Juvenile Court of Williamson County.
- All students must follow the Tennessee State Law, which requires school personnel to intervene with services for students who accrue 5 or more **unexcused absences** during the school year. Excessive Absences from school will result in a **Truancy** Petition being filed with the Juvenile Court of Williamson County.

Level 5 – Zero Tolerance Offenses (Reasoned Judgement)

- State law and the WCBCE have identified other zero tolerance offenses that, depending on the individual circumstances, may warrant “reasoned” judgment by the principal in assigning punishment. These offenses may result in suspensions and placement at the WCS Alternative Learning Center (ALC) ranging from 20 days to 1 calendar year based upon the circumstances and other factors in each case.

Assault	(Fighting) Physical or Verbal towards other students on WCS School Grounds or School Sponsored Activities
Harmful Instruments (Defined)	Possession or Handling with Intent to harm self or others on WCS School Grounds or School Sponsored Activities <i>Instruments other than Firearms - Ex. Pencils, Knives, Scissors, Razors, Compasses, Objects used for blunt force.</i>
Substances (Defined)	Possession, Handling, Use on WCS School Grounds or School Sponsored Activities. <i>Non Scheduled or Non Prescription Medication, Chemicals, Inhalants, Non Regulated Vaping Substances</i>

Level 6 – Zero Tolerance Offenses

- The following are offenses that automatically result in a suspension of 1 calendar year and placement at the WCS Alternative Learning Center (ALC). On a case by case basis the Director of Schools may modify the one-year suspension.

Alcohol	Possession, Handling, Use, Under the Influence of on WCS School Grounds or School Sponsored Activities
Assault	Physical or Verbal towards WCS Staff on WCS School Grounds or School Sponsored Activities
Drugs	Possession, Handling, Use, Under the Influence of on WCS School Grounds or School Sponsored Activities
Drugs (Defined)	<i>Drugs - Any Controlled Substance - Marijuana, THC, Prescription Medication, Government Regulated Substances</i>
Drug Paraphernalia	Possession, Handling, Use on WCS School Grounds or School Sponsored Activities (Defined In T.C.A. §49-6-4202(3)).
Weapons	Possession, Handling, Use on WCS School Grounds or School Sponsored Activities
